**Trail Information:**

On all day rides, **the ride leaves the campground at 10AM.**

On weekend rides, **the ride leaves the campground on Saturday at 10 AM and Sunday at 9 AM.** OHC Members are welcome to ride any day of the weekend and/or join us for potluck on Saturday evening after the ride. Bring your own drinks and a potluck dish or dessert to share.

\*\*\*On pizza day ride, the pizza will be provided, bring your own drink and a dessert to share. The rain date for the pizza ride is June 12<sup>th</sup>. If the pizza ride on May 22<sup>nd</sup> is not cancelled, then we will use the date of June 12<sup>th</sup> for a day ride at Dillon.

There will be slow and fast paced rides offered.

On rainy days stay off the trails, we are preserving our trails.

Please stay on all designated marked trails only.

Camping Fees, if the park charges fees, please pay the fees.

If the park has a log book, please make sure to register that you used the trails.

At all parks and forests ALCOHOL is prohibited. Please observe this law.

All horses that are ponied should be on a lead line. All dogs should be on a leash.

Please clean up all horse manure in the campground and the parking lots. Dispose of properly in the manure bins.

Please record all of your trail mileage on the appropriate forms. The forms can be obtained off the website.
